WARRANTOR'S LIMITED WARRANTY

The WARRANTOR, at its election, will repair or replace any part or parts of the engine or equipment that are found to be defective in material and workmanship or both, under normal use and maintenance, free of charge for the periods specified below. Freight charges on parts submitted for repair or replacement under this warranty must be paid by the purchaser.
